Subject: Placement of students graduating NSQF Level 4 in April/May, 2018 in Applied Learning Skills covered under CSS-VSHSE

As you are aware, NVEQF as a pilot (now Centrally Sponsored Scheme of Vocationalization of Secondary and Higher Secondary Education) was launched by the State Government in Sept. 2012. 40 schools were covered in 2012-13 where 2 Applied Learning Skills (IT/ITeS and Retail/Security/Automobile) in each school were introduced in class 9th & 11th. 100 additional schools were covered in 2012-13 under the revised scheme. Additional 3 skills namely Beauty & Wellness, Patient Care Assistant and Physical Education & Sports were also introduced. Another 100 schools were added under this project during 2014-15 session.

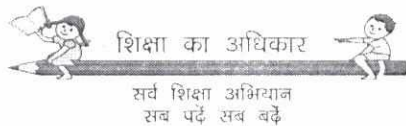
Now the 12th class students in these 240 schools at Annexure-I would be graduating Level 4 in May 2018. NSDC has intimated that as per the mandate of this program, NSDC in association with State Government, Sector Skill Councils along with its training partners will undertake the placement process for the NSQF Level 4 students post completion of final exams.

It has therefore been decided to initiate necessary steps in this regard. For this Parishad is sharing the process that NSDC has followed in the previous years. The process manual and guidelines earlier received from NSDC are enclosed at Annexure-II for your guidance. The salient points to be kept in mind are:

- The placement shall begin only for students of class 12th undergoing vocational training in any Trade who will attain 18 years of age in April/May 2018. Vocational Teacher should initiate the discussion with the students through career counselling sessions. It is recommended that Vocational Teachers be provided material and inputs to explain to the students the career options available, nature of job including apprenticeships that are available and stipend/salary. These details can easily be searched on NSDC website nsdcindia.org.
- It is the responsibility of the SSC and participating NSDC Training Providers to contact relevant companies who may be keen to recruit students. NSDC shall co-ordinate and extend all support in this regard.
- NSDC will identify one or more NSDC Training Providers, engaged by the Haryana for the implementation of CSSVHSE to coordinate the logistics for the Job Fair at each cluster place/places to be identified. It is the responsibility of the nominated Training Provider to coordinate with other Stakeholders, including HSSPP/SSC/ Coordinators as the case may ensure smooth conduct of the event.

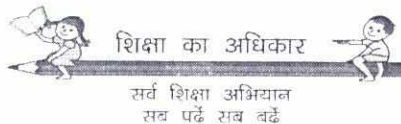
