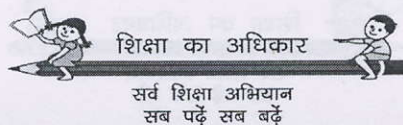
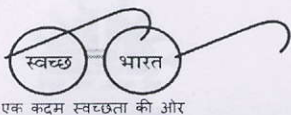

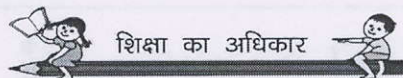
Dear VTPs

The question paper should be objective type of 35 marks out of which 70% should be related to relevant skills and 30% devoted to general knowledge. OMR sheet be appended with the question paper and got evaluated immediately thereafter. Mere appearance and qualifying the written test as also calling for interview will not if so facto established the eligibility of the candidate unless until all the supporting documents as per eligibility conditions are checked by the VTPS. The interview committee shall comprise of representatives of SSC, W.F. & NSDC concerned. The representative of the Parishad will be the member of the interview committee. The representative of the VTP will also be a member of the committee for interviewing candidates who will be opting for the districts allotted to the VTP concerned.

The application fee shall be collected by coordinating VTP for incurring expenditure on account of setting up of question paper, conducting written test, evaluation of OMR sheets, holding interviews etc. in a most judicious manner. The VTP shall maintain proper account of expenditure.

The application fee can be remitted by the candidates through Bank Draft in the name of coordinating VTP.
