

Dear VTPs

Please refer to the deliberations held on 01.07.2016 in SCERT Haryana Gurgaon which was chaired by State Project Director.

As per deliberations held, a decision was taken to conduct written test as also to hold interview for finally shortlisted eligible candidates fulfilling the eligibility conditions i.e. qualifications prescribed (duly shared with you in the meeting), scoring at least 45% marks in the written test in case of candidates belonging to general category and 40% marks in case of reserved categories. Those qualifying the written test will be interviewed for which the selection criteria and marks to be allotted for academics, professional qualifications etc. are being shared with you separately. Since expenditure will have to be incurred for holding written test and conducting interviews, a decision was taken that
