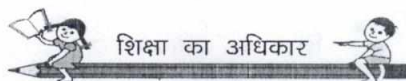

Subject: Utilizing the services of National Service Scheme (NSS)/ Scout for advocacy and national campaign on skills.

Please refer to MHRD Govt. of India, communication dated 01.03.2017 (Copy enclosed) regarding "Utilizing the services of National Service Scheme (NSS)/ Scout for advocacy and national campaign on skills". As a part and process of creating awareness among the Students about vocational skills through guidance, counselling and publicity, the association of NSS/ Scout may also be ensured.

You are aware RMSA Haryana has introduced 14 Applied Learning Skills namely IT/ITeS, Security, Retail, Automobile, Patient Care Assistant, Beauty & Wellness, Physical Education & Sports, Media Entertainment/Animation, Agriculture, Travel & Tourism, Banking Finance Services, Banking Insurance Services, Health Care (Vision Technician) & Apparel (two in each of identified 1001 Govt. Sr. Schools covered till 2017-18 session under the Centrally Sponsored Scheme of Vocationalization of Secondary and Higher Secondary Education (CSS-VSHSE). Therefore keeping in view the contents of MHRD Govt. of India letter under reference, the NSS Services/ Scout may be utilized in the following ways :-

1. **To make aware the dropout students about the CSS-VSHSE scheme:** - NSS Community/ Volunteers may help students by sharing the salient features of the CSS-VSHSE scheme through publicity. Even they will motivate those students who have dropped out after 8th class and suggest them to get enrolled in 9th class & choose one of the vocational skill. It will also help students to get employability with the opportunity of placement after completion of level-4 successfully.
2. **To motivate the parents as well as students who are from EWS (Economical weaker Section) category:** - NSS Community/ Volunteers may help to guide the parents who are not financially strong. The students are given placement assistance after completion of level-4 so that they may opt for employability or they can be entrepreneur within their local area, so that they can financially help their parents.
3. **To help parents counselling & student mobilization during admission process:** - NSS Community/ Volunteers may help students mobilization & parents counselling during admission. They can visit local area (Urban, Semi Urban & Rural) and also brief students about the Applied Learning Skills introduced in their nearby schools.

4. **To help the students find out the Vocational Institutes and ITIs for Higher Studies :-** NSS Community/ Volunteers may help those students who want to opt for Higher Education and are facing problems in mobilizing themselves for their chosen streams after pursuing Level-4. For facilitating such students NSS Community/ Volunteers may find out the Vocational institutes and ITIs for Higher Studies and make aware the students accordingly.
5. **To search the local industries for conducting Field Visits & OJT:** - As organisers, NSS Community/ Volunteers can facilitate visit of students having opted for a particular skill in nearby industries. The interaction between the students and the local industry may be arranged for students of classes XI to XII. They can share the list of local industries with Vocational Teachers & School Principals for further communication.

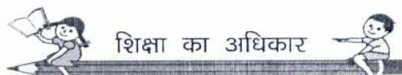

As you are aware, skill development for enhancing employability of youth is one of the priority areas of the Government of India in order to reap the benefits of demographic dividend. In school system, the policy of integration of vocational education with general education is being followed. In order to implement this policy, the Ministry of Human Resource Development is implementing a scheme to provide financial assistance to the States/UTs to promote vocational education at Secondary and Higher Secondary level as a component of Rashtriya Madhyamik Shiksha Abhiyan (RMSA) with an aim to enhance the employability of youth and also to reduce dropout rate at secondary level.

In this regard, I would like to inform you that during a presentation of the Group of Secretaries "Education and Social Development", an observation was made that National Service Scheme (NSS)/Scout may be used for advocacy and campaign on skills. As you are aware, under the component of Vocationalisation of Secondary and Higher Secondary

Education (VS&HSE) under RMSA, there is a provision for granting Rs. 2 lakh per school for different expenses including expenditure on awareness, publicity, guidance, counselling, etc. The States/UTs may utilise this fund/provide comments on engaging National Service Scheme (NSS)/Scout also for advocacy and campaign on skills.

It was also observed during the presentation that High schools may be tagged with nearby ITIs, vocational institutes. Vocational education under RMSA promotes linking the schools with commercial and industrial establishments, ITIs, Polytechnics, Community Colleges, hospitals, farms, etc. depending on the vocation and the nature and level of practical training required for specialized practical work and training in course. Funding provision for the same has also been made in the scheme. It is requested that this provision for providing hands on training to students may also be fully operationalised.
