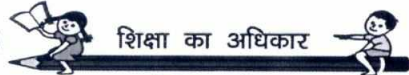

Terms & conditions:-

- 1. Term of Appointment:** The appointment offered is purely on contract basis which will remain operative upto 31.03.2017 or existence of the Project/Scheme, whichever is earlier & subject to satisfactory performance on a consolidated remuneration of Rupees 25,000/- (Twenty Five Thousand only) per month. He/She will not be entitled to any other benefits except those mentioned above. Moreover, the appointment will be purely under Centrally Sponsored Scheme and strictly liable to co-terminate with the completion of Project/Scheme.
- 2. Nature of Appointment:** His/Her services will be purely on temporary/contractual basis. In case the project is continued, the contract will be reviewed by the Parishad based on the performance during the contract period. The appointment is liable to be terminated in case the performance /conduct is not found satisfactory. He/ She will not have any claim for continuation of service beyond the contract period. He/ She will not work and hold any other post or office of profit in any Government, semi-Government and private establishments while working as Vocational Teacher .No right to hold the post shall be conferred upon his/ her on account of his/ her continuance on the post without any extension by the Competent Authority and he/she can be relieved of his/ her duties at any time thereafter, without giving any prior notice.
- 3. Signing of Contract:** He/ She shall sign an agreement with HSSPP on a duly prescribed form as appended herewith which will be the part of this appointment/offer letter.
- 4. Leave:** He/ She will be entitled to avail total 10 days of Casual Leaves one leave per month on pro-rata basis and no other kind of leave/s will be entitled to. The competent authority may terminate the contract without giving any notice in the event of absence of 7 days or more continuously from duty.
- 5. Unauthorized absence:** Unauthorized absence from the duty for more than fifteen days without the prior approval of the controlling officer shall be liable for termination of the contract. The Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.




6. **Declaration:** He/She will have to furnish a certificate to the effect that: i) in case he/ she is married, he/she has to state that he/ she is not having more than one living spouse, ii) He/She will be required to take the oath of allegiance to the constitution of India; iii) He/ She will have to abide by the service regulations of the society as amended from time to time.
7. **Applicability of Government Rules:** The Parishad is not a Department of the Government of Haryana. Provisions of Service Rules like Civil Services rules, Leave rules, General Provident Fund rules, Pension rules and Haryana Civil Services (Punishment and Appeal) Rules, 1987 etc. as are applicable in case of regular Haryana Government employees, will not be applicable to you.
8. **Termination of appointment:** The contract of engagement can be terminated by the appointing authority by giving a notice of one month without assigning any reason thereof or by giving one month's contractual emoluments in lieu of the notice period. However, if his/her term is left short by one month, then his/ her services can be terminated by giving notice or by making payment of contractual salary for that short period. Furthermore, if at any stage he/she desires to resign from the post, he/ she will be required to give one month's clear notice or deposit one month's salary for the period or by depositing the salary for the period by which the notice falls short of one month.
9. **General:**
 - i) If his/her work and conduct are not found satisfactory or in case he/she is found guilty of insubordination or any other misconduct or in case any criminal proceedings initiate against his/her then his/her services can be terminated without giving any prior notice.
 - ii) The person so engaged shall not have any legal right claiming regularization of his/her service etc. in the Parishad, where he/she has been engaged.
 - iii) He/she will perform the duties at the place of posting would be required field duties, liaising with Industries/organizations, collection & compilation of data from field, and other duties as and when assigned by the Parishad.
 - iv) During the period of contract, one shall not be a candidate for election as Member of a Municipal Committee, Municipal Corporation, District Board, Panchayat or any other legislative body.
 - v) He/she will not take up any part time/full time employment or assignments elsewhere or do any business during the period of the contract with the Parishad.



vi) He/she will stay at the assigned school where one is posted unless on tour.

If he/she is willing to accept this offer of engagement, on the terms and conditions mentioned above, he/she may report for duty to the concerned principal of allotted schools on 01.09.2016 and upto 02.09.2016, in any case, failing which this offer of appointment shall be construed to be cancelled.



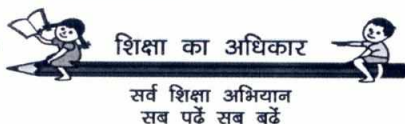

SERVICE AGREEMENT

SERVICE CONTRACT/AGREEMENT

(For Officials working in Project under NVEQF (now NSQF))

Whereas this Service Contract/Agreement is executed on this _____ day of _____, 2016 between Sh./ Sm/S. _____ S/D/o Sh _____ resident of _____ (being referred to for the "_____") which expression shall, unless excluded by or repugnant to the subject or context, include successors and assignees) hereinafter referred to as 'the first party') and HSSPP, Panchkula through its State Project Director having its office at Haryana School Shiksha Pariyojna Parishad, Shiksha Sadan, Sector-5, Panchkula (being referred to for the "Parishad" which term shall, unless repugnant to the subject or context include its successors and assignees) hereinafter referred to as 'the second party')

And whereas Sh./Smt. _____, the first party and Parishad, the second party are willing to enter into Service Contract/Agreement on the following terms and conditions as mutually agreed and binding upon them.

BOTH THE PARTIES HAVE HEREBY MUTUALLY AGREED TO THE FOLLOWING:

1. The services of a person engaged by the Parishad will remain operative till 31.03.2017 or existence of the Project under NVEQF/NSQF, whichever is earlier subject to satisfactory performance on a consolidated remuneration of Rupees 25,000/- p.m.;
2. That the terms and conditions for further continuance /absorption /takeover under RMSA as a consequence of subsuming this program under RMSA as to be decided will be binding;
3. The contract would be reviewed by the Parishad based on his performance on month-on-month during the contract period and the contract may be rescinded if his performance is found unsatisfactory before the expiry of contract period;
4. The services of the person so engaged shall hereafter cease on the expiry of the term without providing his any claim for the regularization of service or any other consequential benefit;
5. The person so engaged shall not have any legal right claiming regularization of his service etc. in the Parishad where he has been engaged;
6. The services rendered by the person engaged shall be under the close supervision of the Parishad;
7. It is understood between the parties hereto that only the Parishad shall have the right to take disciplinary action against the person so engaged;
8. The Parishad shall under no circumstances be deemed or treated as the employer of the person engaged for any purpose, whatsoever, nor Parishad would be liable for any claim (s) whatsoever of any such person;
9. Person engaged will responsible for depositing his income tax and filing return. Photocopy of which should be submitted to Parishad for information within a week after filing return;
10. In case of the death of a person, his remuneration shall be paid to his legal heirs.
