

Please refer to my D.O. letter no. 7/9-2014(NVEQF) dated 24.3.14 vide which details regarding coverage of 100 additional schools alongwith list were sent to you.

I hope you must have passed on these instructions to the schools by now and initiated further action required to be taken at your end. The Distt. Coordinators have also started visiting these schools.

Pending positioning of contractual faculty, a hard copy of Student Hand Book each of the applied skills allotted to these schools is also being delivered during school visits. Even the course content in the respective applied skills is available on PSSCIVE Bhopal Website and can be downloaded by the school Principals.

The school Principals based on the course content should after enrolling 25 students in each applied skill immediately organize guest lectures through local experts (2 Lectures per day per class per trade @ Rs. 400/- for two lectures as honorarium) and keep proper record of topic/topics on which lecture given, name of the expert and honorarium given. The payment can be made out of available funds with the schools. The Department would release the amount immediately on the receipt of separate account details to be opened by the Principals for the implementation of programme (NSQF). Since the Project Account at the State level is being operated through ICICI Bank, the schools are to open the Account with ICICI Bank of the if the services are available locally for quick remittance of funds. In case ICICI Bank is not available locally or is located at a distance more than the other Bank in the locality in that case the Account should be opened with other Bank. In any case it should be done quickly and the details i.e. correct saving Bank Account no. with IFSC code should be mailed to NSQF cell (<u>nveqfharyana@gmail.com</u>) immediately.

Please pass on this information to the schools concerned immediately for follow up action under intimation to me.
