Regarding implementation of the Vocational Education (NSQF) in existing 1065 schools & additional 09 new Schools in Haryana for the session 2020-21.


As you are aware, Department / HSSPP has already been implementing Vocational Education (NSQF) in 1065 Govt. Schools with 14 Skills (02 or 3 skills in each school) from 2012-13 to 2019-20 under Vocational Education (NSQF).

Now, additional new 09 schools (2 skills in each school), list enclosed as Annexure-I, 14 existing Schools of Nuh District where 02nd skill introduced in place of Multi Skill Foundation Course , list enclosed as Annexure-II and 62 existing schools where 03rd skill introduced, list enclosed as Annexure-III are approved by MHRD, GoI in Project Approval Board 2020-21.

Action to be taken by District Project Coordinators in case of 09 new school covered under Vocational Education from Academic Session 2020-21

The orientation by O/o DPC SS Hisar, Jhajjar, Kaithal, Kurukshetra, Panchkula, Panipat, Sonipat & Jind of concerned school Principals as per <u>Annexure-I</u> about the salient features of Vocational Education as mentioned in <u>Annexure-V</u>.

Action to be taken by School Principals in case where 2nd skill introduced in place of Multi Skill Foundation course in 14 Schools of Nuh District from Academic Session 2020-21

2nd skill approved/introduced in place of Multi Skill Foundation course in 14 Schools of Nuh District from Academic Session 2020-21 in the concerned Schools may be seen at Column no. 6 of **Annexure-II**. School Principals of concerned 14 Schools, should take action as per **Annexure-V**, in regard to implement 02nd Skill in their Schools.

Action to be taken by School Principals in case where 3rd skill has been approved in 62 schools from Academic Session 2020-21 in existing 1001 schools (covered from 2012-13 to 2017-18)


03rd Skill approved/introduced in 62 schools from Academic Session 2020-21, in the concerned Schools, may be seen at Column no. 8 of <u>Annexure-III</u>. School Principals of concerned 62 Schools, should take action as per <u>Annexure-V</u>, in regard to implement 03rd Skill in their Schools.

Responsibilities and Action to be taken by Vocational Training Providers

The following measures to be ensured by Vocational Training Providers in 09 new schools, 14 existing schools where 2nd skill is introduced in Nuh District and 62 existing schools where 3rd skill is introduced during 2020-21 by MHRD, GoI.

- 1) In 19 Schools out of 62, where Patient Care Assistant Skill has been approved as a 03rd Skill, the services of existing Vocational Teachers of Vision-Technician in these Schools may be utilized in Patient Care Assistant Skill, if they meets the qualification criteria of PCA Skill and Vision Technician position for such cases should be shown/considered as vacant. Such Vocational Teachers will also continue to teach the students opted for Vision Technician till it gets phased out.
- 2) Remaining schools i.e. after adjustment of Vision Technician Teacher in 19 Schools out of 62, 14 Schools of Nuh District and 09 new additional Schools may be filled by adjusting the services of 02nd Vocational Teachers appointed except GSSS Prem Nagar Ambala City and GSSS Pipli Kurukshetra (as these positions have already been filled up by adjusting the VTs deployed through Department from the Schools having 02 Vocational Teachers in a concerned Skill) by VTP from the Schools having 02 Vocational Teachers in a concerned Skill as per instructions issued in this regard vide letter no. 14/2-2019 (HR-NSQF)/1544, dated 18.04.2019 (copy enclosed). Lists of Schools are enclosed as Annexure-I, II & III.
- 3) After adjustment of 2nd VT services, for remaining positions lying vacant due to any reason, VTPs concerned to map these Schools to nearby Vocational Teacher of relevant Skill/other Vocational Teacher in case Vocational Teacher of relevant Skill

not available in the District, to enrol the students in the Vocational Subjects for the academic session 2020-21.

The adjustment (Mapping) of Vocational Teachers may be made in such a way that their services may be used for initial 03 days of the week in their current place of posting and remaining days of the week in the mapped School. This adjustment (mapping) would be applicable until the Vocational Teachers completes the process of enrolment in the mapped School.

4) In girls Schools only female Vocational Teachers to be appointed, in case any Schools having male Vocational Teachers then the services of those VTs may be adjusted in another Schools.

VTPs ensure that joining and relieving of the VTs deployed by them be completed by 31.08.2020 in any case and submit the compliance report to HSSPP HQ.

You are requested to comply with these instructions/guidelines in letter & spirit and ensure that 40 students are enrolled in class 9th & 11th each, as per the MHRD, GoI norms and transaction of curriculum is being done as per letter no. 10/164 (NSQF)/Covid-19/April /59501-60642 dated 24.04.2020 (Copy enclosed).
