**Subject: Guidelines regarding preparation of question papers for examination /evaluation of divyang students under Inclusive Education.**

2. Your attention is invited vide order No. 1/3-2015 IED, dated 10.06.2015, vide which guidelines regarding separate mechanism in regard to setting of /printing of question papers for divyang students under Inclusive Education were issued.

Govt. of India vide their notification dated 27.12.2016 had issued Rihgts of Persons with Disabilities Act, 2016. As per the Act, the question papers for examination/evaluation for divyang students should be prepared keeing in view their need and requirement according to their disabilities; so that divyang students may be able to understand their question and their evaluation may be made.

In view of the above, Haryana School, Shiksha Pariyojna Parishad in collaboration with Department of Secondary Education has prepared revised guidelines for divyang students with regard to setting/printing of question papers for examination/evaluation as contained in enclosed **Annexure-A**. For this, you are required to follow these guidelines. In future, all monthly assessment test/ annual question papers for divyang students has to be prepared keeping in view these guidelines.

Please take follow up action accordingly and ensure compliance of these guidelines in letter and spirit.

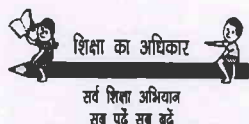

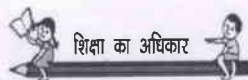
