- The firm/company must be registered bodies with Govt. of State or Govt. of India.
- The firm/company should have minimum turnover of Rs.30 Lacs in last three years i.e. 2016-17, 2017-18 & 2018-19.
- The firm/company should have expertise with android and iOS platform and IT development for mobile applications.
- The firm/company should have executed 3 projects with government/private entities of atleast 10,000 licenses per project in last three years.
- The firm/company should have an English language expert and editorial team with an experience of at least 2 years in content development such as quiz, test etc. for academic/corporate training.
- Preference will be given to companies/entities that have experience of working with government/public organization on the development and execution of mobile application for training of English Learning.

### 1. Evaluation and comparison of proposals

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any finance/budget proposal being opened and compared. The finance/ proposals will be opened only for submissions who passed the minimum technical score of 50 of the obtainable score points in the evaluation of the technical proposals. The technical proposal is evaluated on the basis of its responsiveness to the Term of Reference. In the Second Stage, the finance/budget proposal of all firm, who have attained minimum 50 score in the technical evaluation, will be compared. The contract will be awarded to the firm offering the highest score using a cumulative analysis.

### 2. Criteria for evaluation

This evaluation process consists of 2 stages. Only those companies, that have passed the first technical evaluation stage, will be considered for financial evaluation. During the first stage participants' technical proposals are examined against the following evaluation criteria:

### 4. <u>Scope of Work</u>

The purpose of developing this mobile application would be to enhance the capabilities in the subject of functional English of around 5.5lacs students in Secondary and Sr. Secondary schools in State of Haryana. This mobile application will be accessible to all students for self-learning.

For the above requirement, the frim/company is responsible for overall application architecture and development including concept, design, testing, installation, training and content development framework that allows modular structuring of the content suitable for self-paced mobile learning for Secondary & Sr. Secondary Student. The firm/company should have team of language experts and editorial with communication skill. The application is proposed to be a mobile based app developed for Android and iOS platform.

### 4.1 Following are the selectable tabs

- For Student Interface-
  - 4.1.1 Registration/Login form: A registration form for student with their basic and schools details, so that HSSPP will know how many students are using the app and to get reports in future.
  - 4.1.2 Assessment/ Quiz: Student can get syllabus according to their classes and can take assessment test or quizzes.
  - 4.1.3 Result: The result of each test/quiz will be stored for further progress and reports/monitoring.
- School-wise, District-wise and State-wise ranking of students will be available to students, teachers, monitoring team and in the dashboard of various stakeholders to build positive competition amongstudents.
- Dashboard for State Project Director to view overall implementation status, Director SCERT, DEO, DIET of their respective district, BEO of their respective block and PGT English & School Principal for their respective school.

### 4.2 Data source - Hosting Server & Database

The database platform and application server should be hosted on cloud server for a highly secure and fully managed service. Database should be designed to permit secure logins to update the mobile application database as and when required. There should be an option of populating mobile application database from another database or through secure login interface for manual entry. Database and web server should be Load balanced to handle users inparallel.

### 4.5 User Interface Requirements

- 1. All icons must be crisp, clean, and distinguishable and should be as per guidelines of mobile application platform.
- 2. All buttons and objects must be reactive to touch and work as intended.
- 3. All functions must stay within the mobile platform boundaries.
- 4. All data must be easily viewable on different Mobile platform matrix given above.
- 5. The design/User Interface of the mobile application should be flexible enough for multiple themes/skins
- 6. Free downloads from Google playstore.
- 7. Data representation through graphs and bar chartsetc.

### 4.6 Technology Requirements and Deliverables

- 1. Mobile App development should be in Native languages, responsive, dynamic, online and robust mobile application which is to be supported on smart mobile phones and tablets with o/s such as Android future versions of the mentioned O/S.
- 2. Firm/company will setup and deploy CMS application and Database to cloud server in India with interface via secure login for database update & vendor may also be required to provide facility to import data from predefined parameters in excel format

into the database. The selected vendor will be required to provide quarterly report for hosting up time.

- 3. Firm/company has to ensure the development of mobile application as per guidelines issued by Application stores. For ex: Googleplay.
- 4. The test plans, test cases and results for each of the phases will be shared by vendor with HSSPP.
- 5. Firm/company has to share the Design and get approved by HSSPP and then start development on it.
- 6. User Manual, Admin Manual, Test Cases, Test Plan and QA Results for User Acceptance testing.
- 7. Application Code, Web API's to be handed over to HSSPP
- 8. Deployment document to be provided

### 4.7 Training

For the effective uses of the supplied application licenses & their functionalities, the selected vendor must compulsorily provide classroom training for HSSPP officials. Following training needs are to be provided by Vendor as part of the scope:

- (1) Content Management Training
- (2) Deployment & HostingTraining
- (3) Application SubmissionTraining

### 4.8Technical maintenance support

- 4.8.1 Minimum support period along with hosting is two years after HSSPP's acceptance of deliverables.
- 4.8.2 Support should be provided through email, telephone, remote login or visit to HSSPP office if the situation so demands. The scope of technical support includes rectification of errors within the already developed solution and/or transferring solution from one server to anotherserver.
- 4.8.3 The scope of technical support also includes rectification of errors within the already developed solution, cloud server/database administration, server migration, patching, system upgrades, technical and functional support to HSSPP users etc.

### **4.9Intellectual Property Rights**

The Intellectual Property Rights of the application will rest with HSSPP. The Firm/company will provide the source code of the application as well as database to HSSPP at the time of sign-off.

### 5 Project Duration

Total duration of the project completion is six weeks and providing two years technical maintenance support post Go-Live. Project milestones are as under.

5.1 Milestone 1 – Requirement gathering and SRS – 1 week from acceptance of LoA.

- 5.2 Milestone 2 Software design and development 3 weeks after Milestone1.

### 7 Liquidated Damages/Penalty

- 7.1 If the Firm/company fails to complete in full, all delivery and implementation according to the project schedule, HSSPP reserves the right to recover @ 1.0% of the contract value for each complete week or part thereof, for delay up to a maximum of 10% of contract. Thereafter, HSSPP will have the right to terminate the contract in case of delay beyond 10 weeks and would have the option to execute the project from market at Firm/company's risk and cost.
- 7.2 Failure to maintain hosting uptime ranging 99% to 99.5% may lead in deduction of amount of damages/penalty @10% of payment in Milestone 3, uptime ranging 95% to 98.99% may lead to deduction of payment in Milestone 3 @30% and uptime below 95% may lead to deduction of payment in Milestone 3 @100%.
- 7.3 Non availability of resident support engineer during first year technical maintenance support as per Clause 8.8.2 may lead to deduction of amount @ ₹500/- per day. Failure to attend to a complaint within four hours in the second year of technical support may lead to deduction of ₹400/- per complaint

### 8 Term of Reference

- a) The Firm/company must be registered bodies with Govt. of State or Govt. of India.
- b) Rate should be quote inclusive of the cost of Services, Manpower cost, Transportation, maintenance for a minimum period of 2 years, and report generation and also inclusive of charges of VAT and other taxes as applicable.
