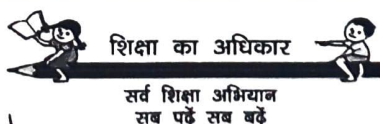
Subject: Regarding Pre-Vocational Exposure to be given to students of Classes 6 to 8 in Govt. Schools.

It gives immense pleasure to inform that Ministry of Education, GoI in PAB 2021-22 has approved 110 Govt. Schools to give Pre-Vocational Exposure to students of Classes 6 to 8 in Govt. Schools and you must feel proud that your School is one among them (**list enclosed**).

Pre-vocational education has been conceptualized in Samagra Shiksha as the integration of work based activities with teaching-learning processes, rather than a separate add on to the existing scheme of studies of education from Classes VI- VIII. The general education teachers of languages, mathematics, science, social sciences, art, music and work experience would be involved in the organization of the skill-based activities related to the themes that they are teaching.

The Principal or the Headmaster of the concerned school shall act as the Chief Coordinator of the programme and shall ensure seamless coordination and effective Pre-Vocational Exposure to students of Classes 6 to 8 in Govt. Schools along-with Upper Primary Teachers and if needed, support may be taken from concerned Vocational Teachers.

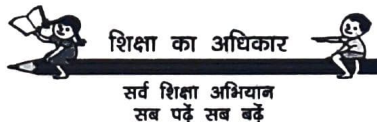

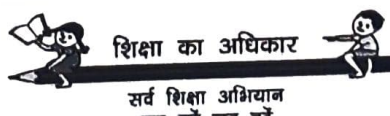

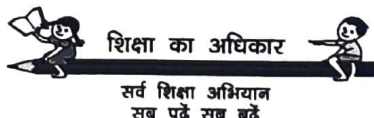
