1487 posts of Assistant Manager (MIS) have been created at Cluster Level. As per this office letter dated 30.09.2016 all the SIMs who were in position were aksed to give their acceptance for the post of AM (MIS) in DPC Office. Those who had submitted their acceptance were allotted clusters by the concerned DPC. Now a policy has been framed for online counseling of Assistant Managers (MIS) to allot them Cluster Resource Center (CRC). The following process will be adopted:


- 1. Criteria for deciding the claim in the deployment of Assistant Managers (MIS).
- (i) Each AM (MIS) will have to select four districts, in order of preference.
- (ii) In all the selected districts they have to select all clusters preference wise.
- (iii) Cluster will be allotted as per criteria given below:
- (iv) Overall Maximum Marks -40
- (v) (a) Rank Weight age (maximum 20 Marks)

A secured Login ID and Password will be allotted to all AMs(MIS) for filling up personal data/information and choices of Districts and clusters.

Other conditions:

- 1. It is mandatory for all AMs (MIS) to participate in transfer drive. If any one does not participate in online transfer drive then he/she will be allocated vacant cluster after transfer drive manually.
- 2. Documents and certificates related to point no. 2,3,4 &5 should be verified/attested by concerned DPC which will be uploaded for transfer.
- 3. In case no cluster has been allotted as per his/her choice in four districts then nearby district vacant cluster will be allotted manually with his/her consent.
- 4. After completion of transfer drive, he/she will not be transferred manually through out year except administrative grounds during the year.

Timelines:

- 1. Online requests for transfer from 25th March to 29th March 2017 (link will be available on www.hsspp.in from 25.03.2017)
- 2. Transfer list will be declared on 31st March 2017.
- 3. The joining date will be 1^{st} April 2017 to 3^{rd} April 2017 at new stations for all the AM (MIS).
