**Sub: Extension and recruitment of Vocational Trainers deployed by VTPs in 990 schools covered under CSS-VSHSE in alignment with NSQF.**

Sir/Madam

Your attention is invited to the subject cited above.

As per communication no. 2/9-2016(HR NSQF) dated 20.3.2017 District level Committees to be chaired by ADCs concerned were constituted to consider and recommend the extension in the contract of vocational teachers deployed by you for one year beyond 31.3.2017. The committees while making recommendations were required to comply with certain parameters as shared with them vide communication under reference as also dated 01.04.17,21.04.17,05.05.17 &18.5.17.

In the process, names of the some vocational teachers have not been recommended by the District level committees. There have been a number of representations from teachers staking their claims for extension emphasized that they meet all the eligibility conditions. These were duly forwarded to the DPCs. Out of these committees on review have recommended some names for extension and the extension orders are to be issued by the VTPs.

Now still there are cases for which the VTPs have been representing that these teachers too are eligible. In addition there are cases of teachers who are still insisting that they are very much eligible despite VTPs and committees view that they are not eligible.

With a view to logically conclude and resolve such issues so as to ensure that no unnecessary hardship, harassment, in justice is done to any teacher, a committee under the supervision of the undersigned and comprising of the following has been constituted to examine all such cases:-

1. Programme Manager (HR NSQF)
2. Consultant (Pedagogy)
3. Sh. Ashok Kumar, Coordinator
4. Dy. Supdt. NSQF
5. Concerned VTPs
6. Concerned NSQF Coordinator
