Dear Principals (As per list enclosed)

Department of school education has been implementing CSS-VHSE in financial partnership with MHRD Government of India. The project of National importance has been conceptualized to enhance the employability Skills of students in integration with academic stream.

Haryana is the only state having launched the Pilot with 40 schools and 4 skills (2 skills in each school). Now other states in view of National mandate of skilling the youth of the country have started implementing the scheme.

Presently 990 Govt. Senior Secondary Schools with 14 Skills (2 skills in each school) stand covered and your school happens to be the one. These are practical based Skills, the students are to be trained as per expectations of the Industry and the investment is huge. Therefore, it is the responsibility of all of us that resources provided for are put to optimum use. Each school has therefore been identified based on certain parameters which inter alia include enrollment of 25 students per skill starting from Class 9th.

As per data made available out of 990 Schools, the schools as listed in the enclosed format have enrolled less than 20 students.

In the given background if the situation is not improved from the academic session 2017-18, the Department will have no other option except to close / shift the Skill and treat this as your underperformance for taking final decision at Govt. level.

Please respond within 10 days whether you will be able to pool all your energies for ensuring enrollment of 25 students in the identified Skill in Class 9th from academic session 2017-18.

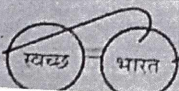
