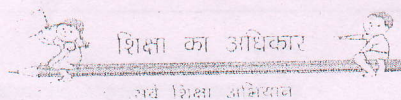
Notification


